## NATIONAL OPEN CALL FOR ENTRIES

From Paul Gauguin to Amedeo Modigliani, artists have been inspired and entranced by the culture, people, and artistic vision of a foreign land. Whether it's their ethnic technique or the exotic appearance, artwork influenced by a foreign country opens the minds of fellow artists and patrons alike – displaying a visual passport to a new, beautiful and unfamiliar world. This show celebrates that global inspiration.

This is an "artist-based" exhibit. Jurors will choose artists based upon their artist's statement, personal art philosophy and submitted artwork. Artists can also submit a website portfolio for review if their collection isn't completely finished by the Application Deadline. Once chosen, a minimum of 3 pieces of art (inspired by one global locale) will be displayed per artist in individual art stations.

This juried exhibit is open to DRA (Del Ray Artisans) members and non-DRA members.

# **Submission Directions and Guidelines**

# IMPORTANT! Completed work size limitations are as follows:

- **2D** Finished work (including frame) cannot exceed 120 inches in total when you add length + height + width; and cannot weigh more than 40 lbs.
- **3D** Finished work (including armature or display stand) cannot exceed 120 inches in total when you add length + height + width; and cannot weigh more than 50 lbs.

# These restrictions are necessary for safety, and to insure that the artwork is not displayed in a confined and crowded manner.

1. Artists must submit a minimum of three (3) images for the nonrefundable entry fee (DRA members: \$10; non-members: \$20). Additional artwork submitted above three (3) is an additional \$3 per image. All work submitted for consideration MUST be available for the ENTIRE run of the show, which includes intake (June 27) throughout the

- show, when it ends July 18th at 6 pm. (June 27 July 18, 2010).

2D work requires one photo per art piece. 3D work should be photographed front, back and side per art piece. This will allow the jurors to judge your work fully. Digital images cannot exceed more than 1500 pixels on any side and the resolution cannot be more than 100 dpi (this is for your own web protection). All digital files must contain the artist's last name and title of the submission (i.e., doe\_tree.jpg). \*Please make sure to add an underscore ( \_ ) between name and art title.

- 4. The nonrefundable entry fee must accompany each entry form. DRA members: \$10; non-members \$20. \$3 fee for each additional artwork image submitted above the initial three images. Checks or money orders are to be made payable to the Del Ray Artisans.
- 5. Entry form, fee, and JPEGs must be received no later than midnight, May 28<sup>th</sup>.
- Artists must insure their own artwork for the duration of the show, which includes shipping insurance.
- 7. DRA will keep a digital copy of accepted works and reserves the right to reproduce the images for all media and publicity purposes, with proper attribution.
- **8. Delivery:** Local artists may hand deliver accepted works to the gallery on Sunday, June

27 from 3 - 7 pm. Non-local artists are responsible for shipping their accepted works in sturdy, reusable boxes or containers, <u>for delivery between Monday</u>, <u>June 28 and Wednesday</u>, <u>June 30</u>. **Return shipping must be prepaid and enclosed with the artwork**. Please note that DRA is not responsible for any damage incurred in transit so please make sure proper packing and padding is included with the return postage. **Additional shipping directions for non-local artists will be provided with the artists' notifications**.

- 9. Accepted 2D work must be attached with secure hanging devices and wire able to support 40 lbs; 3D work must be suitably prepared with instructions and or photos for installation. DRA reserves the right, in its sole discretion and interest, to refuse to exhibit any work regardless of any juror selection. No alternative work will be accepted as a substitute for any selected work.
- 10. **Sales** For each piece of artwork sold during the exhibition, a 20% tax-deductible donation of the sale price will be automatically deducted. By the artist's choice, a payment will be mailed via check, within 30 days of the exhibition closing.
- 11. **Liability** Every possible care will be taken of all artwork, but DRA assumes no responsibility for loss or damage. Submission of work for this exhibit constitutes agreement with all terms and conditions stated above.
- 12. Gallery Sitting Artists chosen are required to sign up for gallery sitting times during the run of the show and will be supplied the Gallery Sitting Schedule along with their acceptance letter. Non-local / non-member artists are exempt from gallery sitting. This exemption results in the higher entry fee,

which allows DRA to hire a temp, if necessary, to gallery sit.
